### **General Instruction-**

1. Financial Advisor shall be a whole time officer of the University appointed by the Chancellor either on deputation or by re-employment from amongst the officer of Indian Audit and Accounts Service or from any other Group A Accounts Service of Government of India.

3. The application shall be submitted in a prescribed format, which can be downloaded from website of Raj Bhavan, Jharkhand, Ranchi having URL [www.rajbhavanjharkhand.nic.in](http://www.rajbhavanjharkhand.nic.in)
4. Recent self attested passport size photograph and signature of applicant shall be scanned at proper place.
5. The applicants need not submit any certificates in proof of his/her educational qualification.

6. The maximum age limit for appointment of Financial Advisor shall be 62 years on the date of advertisement and shall hold office for a period of three years with effect from the date he/she assumes charges.
7. Incomplete application form is liable to be rejected.
8. Suppression of any material information or misrepresentation in the application shall automatically disqualify the candidate and further may attract prosecution.
9. Application received after due date and time shall not be considered.
10. Canvassing in any form will invite disqualification.
